

2023/24 Results

- Curl BC Financial Report Details
- Bottom line -\$127,467 (\$89,000 in year end funding not included)
- Fund balances
 - General 262,485
 - Capital Assets 73,978
 - Restricted Fund \$32,550
 - Operating Reserve Fund \$60,000

The Funds

- General Fund core operations in all three pillars
- Invested in Capital Assets Fund value of funds invested in capital assets net of amortization
- Restricted Fund Specific grants restricted to be spent on specified purposes or returned
- Operating Reserve Fund Available to member facilities in urgent need of low cost loans


Best Practices in Member Facility Governance & Operations



- Curl BC's HP Program went to an individual application system in 2023/24.
- In total, there were 50 funded athletes out of these 50, 35 of them went to a national championship in Men's, Women's Mixed Doubles, U21, U18, Usport and PacWest.

Sustainability through Effective Revenue Generation and Good Corporate Governance



- In total, the Provincial Government provided \$470,000 in support this past year.
- Federal support provided an additional \$45,800 during the 2023-24 season.
- Curl BC initiated a very successful online and in-venue 50/50 raffle in 2023-24 to benefit its member facilities. A total of \$178,170 worth of tickets were sold of which 50% went to 6 lucky winners, 40% to the beneficiary selected by the purchaser and 10% to cover the costs of the raffle. In all, 82 member facilities and 3 affiliated associations were designated as beneficiaries.
